Camilo Parra Cruz and colleagues, article published in English); a training method for implementing DTT in university students (Luiz Alexandre Barbosa de Freitas and colleagues); an experience in behavior-analytic therapy of a university student diagnosed with major depressive disorder, with psychotic features and academic giftedness (Taize de Oliveira and Alessandra Turini Bolsoni-Silva); Effects of the supervisor-supervisee relationship on psychotherapy quality (Luciano Barbosa de Queiroz and Luc Marcel Adhemar Vandenberghe); characteristics of a Brazilian prototype of Dialectical Behavior Therapy (DBT) (Tamires Pimental Souza and colleagues); behavioral components of bullying behavior (Leticia Batista de Lima and colleagues); behavior-analytic intervention for girls in institutional care (Tassiane Aparecida Ferreira Valin and Giovana Munhoz da Rocha); caffeine administration and problem-solving in rats (Marcela Prata Oliveira and colleagues); protocol for anger management in patients with acute myocardial infarction (Karine Elisa Schwarzer Schmidt and colleagues); and an intervention focused on eating behavior and dietary prescription in patients with Type 1 diabetes (Aline Leão Reis and colleagues).

The Literature Review section covers the following topics: Gamification and teacher training (Fabiana Paula Fieldkircher and Silvia Regina de Souza); Cooperation (Marília de Almeida and colleagues); Multiple Exemplar Training (Lucas Cabral Aranha de Lima, Carlos Barbosa Alves de Souza); and Mindfulness-based interventions for acute mental disorders (Stephany Gama and colleagues).

The volume features three Conceptual Articles covering the following topics: graphical analysis of data in single-case experimental designs (Milena Fidelis da Conceição and colleagues); Verbal Behavior Development Theory (Djenane Brasil da Conceição and colleagues, article published in English); and public policies and behavior analysis (Diego Mansano Fernandes).

The Special Section Behavior Analysis, Game Theory, and Behavioral Economics presents four research studies: NetLogo implementation of norms and metanorms (Diogo Conque Seco Ferreira and colleagues, article published in English); ENEM exam scores and studying (Juliany Christine

Paiva e Silva and Dyego de Carvalho Costa); the influence of contextual variables on dishonest behavior (Diogo Conque Seco Ferreira and colleagues); and ethical self-control in the Commons Dilemma game (David de Lima Rabelo and Aécio Borba).

Five studies conclude Volume 24, corresponding to the Special Section: History and Teaching of Behavior Analysis: training future higher education teachers for instructional programming (Fernanda Torres Sahão and colleagues); dialogues between Behavior Analysis and Social Psychology (Diego Zilio and Amanda Gonçalves); Experimental Analysis of Behavior (Joene Vieira-Santos); the functions of the publication *Boletim Contexto* (Daniel Afonso Assaz and colleagues); and teaching in higher education by students from postgraduate programs in Behavior Analysis (Gabriel Gomes de Luca and colleagues).

I hope that the articles presented here will inform good practices and bring forth even more relevant and challenging research questions.
